**Subject: Enquiry regarding purchase of computers in the year
2003- 2004 by Director Floriculture, J&K.**

**Government Order No:- 06-Flori/G&P of 2018
Dated :- 25 -01 - 2018**

WHEREAS, the State Vigilance Organization received a complaint against the then Project Officer Bahu Fort Sh. Kulbshan Kumar Sharma and the then Deputy Director Floriculture Central Sh. Anoop Koul regarding purchase of computers at highly exorbitant rates, causing loss to the State exchequer; and

WHEREAS, the surprise check was conducted and all relevant records were scrutinized by the State Vigilance Organization in the year 2006; and

WHEREAS, the State Vigilance Organization has forwarded the case to the Administrative Department on 22.11.2006 with the direction to take departmental action against the accused officers for having caused loss to the state exchequer; and

WHEREAS, the case has been examined in the department and it was decided to hold a departmental enquiry against the accused officers; and

WHEREAS, vide Govt. Order No. 33/flori/G&P of 2015 dated: 23.12.2015, Mr. Ravinder Kumar (IAS), Deputy Secretary to Government, Floriculture Department was appointed as Inquiry Officer with the mandate to conduct preliminary enquiry into the matter within a period of four weeks and furnish findings/recommendations within stipulated time; and

WHEREAS, the Inquiry Officer has submitted the enquiry report with the recommendations that both the officers have not admitted their charges and also not proved otherwise, both should be exonerated with caution of warning for remaining vigilant in future; and

WHEREAS, the recommendations submitted by the Inquiry Officer have been examined and accepted by the competent authority;

Now, therefore, in view of the above, the charges leveled against the then Project Officer, Bagh-e- Bahu Jammu Sh. Kulbshan Kumar Sharma and the then Deputy Director Floriculture (Central) Sh. Anoop Koul are hereby dropped and both the officers are exonerated from the charges leveled against them.


