Subject: Creation of one supernumerary post of Helper in the Floriculture, Gardens & Parks Department.

In pursuance of Rule 3 of J&K Daily Rated Workers/Work Charged Employees (Regularization) Rules, 1994 and in terms of O.M. No. referred above, sanction is accorded to the creation of 01 (one) supernumerary post of Helper in the pay scale of 2550-3200 (pre-revised) in the Floriculture, Gardens & Parks Department for regularization of services of Late Ab. Khaliq Mir, R/o Nadirgund Peer Bagh, Srinagar w.e.f 01.04.1996 to the date of his death viz 18.12.1998 against a said supernumerary post, subject to the following conditions:-

- i. The Directorate shall verify the records to establish genuineness of the claim.
- ii. The Directorate shall get condonation of breaks of 153 days and delay in processing the case, from the Competent Authority.
- iii. The Directorate shall verify the continuous working from the date of initial engagement to date of death and drawal of wages at notified rates shall be established/certified by the concerned HOD.
- iv. The deceased was eligible for regularization and fulfilled all conditions as laid down in SRO 64/1994.
- v. Relaxation of age/ qualification, if required, shall be considered by the Department with prior approval of the Competent Authority.

This order is subject to all the terms and conditions set by Finance Department from time to time for such cases and other guidelines as laid

down in the Jammu & Kashmir Daily Rated Workers/Work Charged Employees (Regulation) Rules, 1994. The formal orders of regularization shall be issued by the Director, Floriculture, Kashmir after fulfilling the requisite conditions as laid down in SRO-64 of 1994 dated: 24.03.1994 and conditions put forth by Empowered Committee in its Minutes of 11th Meeting.


