Sanction is hereby accorded to the temporary appointment of Mr. Vijay Kumar B/o Late Jagmohan Lal (Ex-Gardener) R/o Village Badhori P.O Rahya, Tehsil & District Samba, as Gardener (Class-IV), in the pay level SL1(14800-47100) in the Directorate of Floriculture Jammu in relaxation of prescribed qualification in terms of Rule-7 of SRO-43 of 1994.

The appointee shall report to Director, Floriculture, Jammu within a period of 21 days from the date of issuance of this order and shall be allowed to join only on the production of following documents/certificates to be verified subsequently:-

- 1. Academic Qualification Certificate.**
- 2. Age and Health Certificate.**
- 3. Permanent Residence Certificate.**
- 4. No Loan Certificate under self employment scheme from DIC concerned and Employment Department.**
- 5. All other relevant documents as are required under SRO-43 of 1994.**

The appointee shall be initially on probation for a period of two years. If on verification, any certificate/document, produced by appointee, proves to be fake or forged, the appointment shall be deemed to have been cancelled ab-initio.

The salary of the appointee shall not be drawn and disbursed unless a satisfactory report about the verification of his character and antecedents is received from the Inspector General of Police, CID, to whom a reference shall be made by the Director, Floriculture, Jammu.

If the appointee fails to join within a period of 21 (twenty one) days from the date of issuance of this order he shall forego his right to appointment which shall be deemed to have been cancelled abinitio without any further notice.
