Subject: Enquiry into not following norms & guidelines for granting permission/renewal to the Photographers for photography proposed at Bagh-e-Bahu, Jammu during the period 2009-10 against Sh. Kulbushan Kumar Sharma, then Director Floriculture Jammu.

WHEREAS, the State Vigilance Organization received a complaint against Sh. Kulbushan Kumar Sharma, then Director Floriculture Jammu regarding not following norms & guidelines for granting permission/renewal to the Photographers for photography proposed at Bagh-e-Bahu, Jammu during the period 2009-10; and

WHEREAS, the verification was conducted into the allegations levelled against Sh. K. K. Sharma Director Floriculture Jammu and all relevant records were scrutinized by the State Vigilance Organization; and

Whereas, the State Vigilance Organization, vide No. SVO/veri-Jmu-21/10-2676-77 dated 28.10.2011, recommended to initiate regular departmental action against Sh. K. K. Sharma, Director for not following norms/guidelines in corroborated in Govt. Order No. 17-CM(F) of 2008 dated 08.05.2008 while granting/renewal of permission for photography trade in the premises of Bagh-e-Bahu, Jammu; and

Whereas, the department also issued the Article of charges and statement of Imputation of conduct in support of Article of Charges against the below mentioned officers/officials, who remained posted in Directorate office Jammu: -

However, these officers/officials denied the charges in their replies; and

Whereas, vide Government Order No. 02-Flori/G&P of 2016 dated. 04-01-2016, Shri Sunil Misri, Project Director, Bagh-e-Bahu, Jammu was appointed as Enquiry officer with mandate to investigate the allegations in terms of Jammu and Kashmir (Civil, Classification & Appeal) Rules, 1956 and furnish findings/recommendations within stipulated time; and

Whereas, Inquiry Officer has submitted the enquiry report with recommendations that the officer has not admitted the charges and also not proved otherwise, he should be exonerated with caution of warning for remaining vigilant in future; and

Whereas, the recommendations submitted by the Inquiry Officer has been examined and accepted by the competent authority.

Now therefore, in view of above the charges levelled against Sh. Kulbushan Kumar Sharma then Director Floriculture Jammu are hereby dropped and officer is exonerated from the charges levelled against him.


