**Subject: Regularization of Contractual employees working in the Directorate of Floriculture, Kashmir.**

As recommended by the Empowered Committee constituted in terms of the Jammu and Kashmir Civil Services (Special Provisions Act, 2010), sanction is hereby accorded to the regularization of Contractual Gardener Sh. Mulkh Raj S/o Sh. Banarsi Lal, R/o R.S. Pura, Jammu and Sh. Deepak Katoch S/o Sh. Swami Raj, R/o Muthi, Jammu as "Gardeners" in the Pay Scale of Rs. 4440-7440 with Grade Pay of Rs. 1300/- in the Directorate of Floriculture, Gardens & Parks Department, Jammu against available post, prospectively.

Further, the regularization of the above officials shall be subject to the following conditions:-

1. That the appointee has not been selected by any recruiting agency/ or appointed in any other government department;
2. That the allowances other than what were admissible/ due has not been drawn;
3. That the employee are working against clear vacancy/post and has not been conveyed/recommended earlier by the Empowered Committee; and
4. That the concerned authority shall verify their original qualification, date of birth, permanent residential certificates & all other certificates as provided under rules;

5. That if at any time, it is proved that the certificates/testimonial furnished by the employee/s are forged/fake, the appointment shall be deemed to have been cancelled abinitio;
6. That the status of appointment is only contractual, consolidated or adhoc;
7. That no disciplinary or criminal proceedings are pending against the employee/s.
8. That the appointee/s are not part time or seasonal including those whose wages are paid out of local funds or contingent grants.


