**Subject: Revision of Entry Fee/Tickets in respect of Gardens and Parks being maintained by the Department of Floriculture, Gardens and Parks.**

**Government Order No: 06 -JK (Flori) of 2024**  
**Dated: 15-02.2024**

In supersession of all previous orders on the subject, Sanction is hereby accorded to the revision of Entry Fee/Tickets of all Gardens/ Parks which are maintained by the Department of Floriculture, Gardens and Parks. The revised rates are as under:-

S. No	Name of Park/Garden	Entry Fee (per head including GST)
1	All Parks and Gardens (except Tulip Garden and Children Park Hazuri Bagh, Srinagar)	1. Adult= Rs. 30/- 2. Child below 12 years Age= Rs. 15/-
2	Children Park Hazuri Bagh, Srinagar	1. Adult/Child= Rs. 10/- (Adults visit the garden along with their child as Guardian)
3	Tulip Garden Srinagar	1. Adult = Rs. 75/- 2. Child below 12 years Age= Rs. 30/-

Besides above, the following revised rates shall be applicable to the Foreign Nationals:-

S. No	Name of Park/Garden	Entry Fee for foreigners (including GST)
1	All Parks and Gardens (Except Tulip Garden)	Rs. 100/- per head (both adults/children)
2	Tulip Garden, Srinagar/Jammu	Rs. 200/-Per head(both adults/children)

The revised rates shall be applicable from 01-03-2024, however in case of already outsourced Parks & Gardens; the revised rates shall be applicable from the date of allotment of New Contract/ Extension of the contract as the case may be.


