4. No Loan Certificate under Self Employment Scheme from DIC and Employment Department and any other certificate/document required under rules.

The salary of the appointee shall be drawn and disbursed only after receipt of verification of character and antecedents report from the concerned quarter. The appointee

shall at the time of joining furnish an affidavit to the effect that in case any adverse report regarding his character and antecedent is received, she shall have no right to claim the appointment and her appointment shall be deemed to have been cancelled ab-initio.
